### **Course Description**

This course is intended for students who have never studied this subject before. It will explain the role of law in society by using everyday examples. This will be followed by an examination of a broad range of issues related to law, including types of law and judiciary systems. This course also includes on-site learning by visiting the courts and witnessing what students learned in the classroom. The ultimate objectives of the course are: acquisition of legal thinking; fostering an interest in law.

### **Course Objectives**

- (1) To understand the role of law in society
- (2) To acquire basic knowledge about legal systems and laws
- (3) To acquire a habit of legal thinking

Visit to the court house. The Second paper due.

# Week 8: Criteria of Trials

Sources of law as the basis of trials.

# Week 9: Interpretation of Law

Legal syllogism, with case studies.

# Week 10: Lecture by way of Audiovisual Material

Work of lawyers (audiovisual materials will be used in class), to be followed by a writing assignment of thoughts and impressions from the audiovisual materials. The third paper due.

# Week 11: Law in Practical Life

*Houterasu* (Japan legal support center), as an everyday institution for legal consultation with a talk by a practitioner.

# Week 12: Learning from Recent Cases (1)

Case studies and discussion of everyday legal issues.

# Week 13: Learning from Recent Cases (2)

Case studies and discussion of everyday legal issues.

# Week 14: Learning from Recent Cases (3)

Case studies and discussion of everyday legal issues.

# Week 15: Course Wrap-up

Review and Q & A to deepen student' understanding.
