### **Course Description**

The Local Autonomy Act is a body of laws that define mechanisms of local government (at the prefectural, municipal, town and village levels) and the rights and responsibility of residents. It is also a subfield of the Administrative Law. Japan's local government system is provided for in Article 92 *et seq.* of the Constitution and the Local Autonomy Act.

This course seeks to foster student understanding of how the concept of local government, as provided for in the Constitution, is embodied in local governments, institutions of government most immediate to citizenry. It will also examine characteristics of local government, the relationship between the national and local governments, and the rights and responsibilities of residents.

## **Course Objectives**

Local governments provide a variety of services for their residents (providing water, garbage collection, police and fire fighting). They also provide diverse rights (national health insurance, elder care insurance, etc.). At the same time, they enforce various regulations (pet registration, requirement for pet vaccination, approval of restaurants and lodging facilities).

These services deeply embedded in our everyday life are rarely provided by the national government and they are generally local government's bailiwick. The role of the local government is important. This course aims to helping students learn the legal bases of services provided by local governments. It also seeks to help students understand their rights and responsibilities as citizens through everyday examples.

### **Prerequisites**

Administrative Law I (General Remarks) and Administrative Law II (Remedies) are recommended but not required.

Kinds of local governments prescribed in the Constitution of Japan and the Local Autonomy Acts.

#### Week 4: Parliamentary System of Local Assembly and Position of its Members

Authority of prefectural, municipal, town and village assemblies and position of the member of local assemblies and method of election.

### Week 5: Position and Authority of Head of Local Self-governance

Position, role and authority of the head of a local self-governance and its relation with the local assembly.

# Week 6: Executive Organs and Administrative Organization

Concept of pluralism of the executive organs and the structures of the executive organs.

# **Week 7: Administrative Committee System**

Significance of the administrative committee and its relationship with the head of the local self-governance.

# **Week 8: Rights and Obligations of Local Residents**

Status and the rights and obligations of a local resident.

## Week 9: Decision-making and Direct Request System

Significance of the direct request system prescribed in the Local Autonomy Act while the indirect democracy is the general principle.

# Week 10: Local Resident Audit Request to Local Authority

Request by the local residents for an audit of the local authority as a system for the local residents to check the administrative works of the local self-government.

# Week 11: Local Residents' Suits against Local Self-governments

Local residents' suits as a system for the local residents to check the administrative works of the local self-government.

#### Week 12: Significance of Ordinances

Significance of ordinances as regional legislation and the relationship with laws and ordinances.

# **Week 13: Framework of Local Government Finance**

Accounting systems of the local self-governments and the financial relevance of national government and local self-governments.

#### Week 14: Public Facilities

Rights of local residents to use the public facilities established by the local self-government.

# Week 15: Concerned Legal Framework/Dispute Resolution Procedure

Types of administrative matters handled by the local self-governments and procedure to self disputes between the national government and a local self-government.

### **Preparation and Follow-up**

Read the relevant chapters of the textbook to prepare for the class. For review, organize lecture notes soon after the class. Read the textbook and supplementary materials, outline key points of the lecture and identify questions you may have. Come to the next class prepared to ask those remaining questions.
