

To those who wish to apply for tuition exemption/collection deferral

Please check if you are eligible; those who wish to apply need to follow the designated procedure.

If you wish to apply for exemption and/or collection deferral, please do NOT pay the tuition. Please note that once payment has been made, you will be deemed ineligible.

Applicants will be deferred from paying the tuition until the results of the selection process are notified.

● If you fall under any of the following categories, you will not be eligible for tuition exemption/collection deferral.

- Japanese Government Scholarship students, Government-sponsored international students, Research students, and Non-degree students.
- If you are studying beyond the standard period without any valid reason, or if you will exceed the standard period during the semester you are applying for.
- If the applicant has already paid the tuition.
- If the applicant has submitted the withdrawal or the leave of absence before the results of the screening.

● Please check the information on the respective websites before applying, and submit your application at the respective application period.

● Regarding tuition exemption/collection deferral, please check the university website regularly.

① Tuition Exemption/Collection Deferral due to Financial Reasons etc.

*This applies to graduate students; undergraduate students can only apply for collection deferral.

*Those who wish to apply for it must NOT pay the fee.

Those who meet any of the following conditions may be exempt from paying the full or half amount of tuition, and the payment may be postponed based on the applicant's application and after screening. Please note that not all applicants can be approved due to budget and household criteria.

- If applicants have financial difficulty paying the tuition by the due date and have an excellent academic record.
- If the person who mainly supported the applicant's educational expenses passed away within six months before the due date (or within one year before enrollment for tuition for the first semester of enrollment).
- If the person who mainly supports the applicant's educational expenses has been affected by a natural disaster within six months before the due date (or within one year before enrollment for tuition for the first semester of enrollment).
- If the applicant has any valid reason deemed by the president. (e.g., the person who mainly covered the applicant's educational expenses has lost his/her job. {This excludes voluntary resignation or mandatory retirement.})

【How and When to Apply】

• Spring semester tuition : Please apply in April.

• Fall semester tuition : Please apply in October.

The details of the application procedure and requirements will be announced on the university website on the next column. (Students can check the information on the Universal Passport after the enrollment.)

②Tuition Exemption due to an Excellent Performance on the Entrance Exam by Graduate School students

*Those who wish to apply for it must NOT pay the tuition.

*Only first-year graduate students are eligible.

*Both tuition exemption/collection deferral for financial reasons and tuition exemption for excellent grades at the exam of admission to the Master's Program can be applied for at the same time.

If any of the following applies to you, upon your application and after screening, you will be exempted from paying half of the tuition for the spring and fall semester for one year after the admission.

However, the tuition exemption period may be terminated after half a year depending on the student's academic progress.

- Those who are currently working as teachers or in medical institutions, companies, etc., and have passed the examination with excellent grades.
- Those who have passed the exam of The United Graduate School of Professional Development of Teacher (The School Leader Program or The Management in and on School Reconstruction Program) with excellent grades.
- Those who have passed the Special Selection for the Master's Program of Engineering (Entrance Examination for Selection on Recommendation) with excellent grades.
- Those who have passed the Graduate School of Medicine with excellent grades using the ATM program and other programs.

【How and When to Apply】

• April Entrants : Please apply after the enrollment (in April).

• October Entrants : Please apply after the enrollment (in October).
